Applicant proposes to construct a three-story mixed-use building to include 1,900 SF of retail on the first floor and 24 residential units on the second and third floors.

Jordan Friedman, Esq. appeared as an objector to the application representing Terrance Golden of 24/26 Metzler Place and 4 Walnut Avenue and submitted a copy of the Applicant's LOI from the NJDEP that was marked as Exhibit O-1, and a copy of an OPRA request with complaint response form was marked as Exhibit O-2.

#### The Board was in recess from 9:23 pm to 9:35 pm.

Chairman Gerecht polled the Board to find out which proposed architectural rendering was preferred in order to best move forward towards a decision and finalizing of variances required. The majority of the Board members noted they prefer the design of the proposed Exhibit A-9.

During discussion, the Board was appreciative the Applicant had been agreeable to suggestions made and that they offered modified architectural options for the Board to consider. As the use variances had previously been approved by the Board, the general consensus was that the proposed building will be a good use in the area and will have less of an impact on the area as a residential community vs. a fully commercial use.

Upon motion made by Mr. Grosskopf and seconded by Mr. Gianakis, the application was approved with conditions subject to a memorializing resolution by the votes of Mr. Grosskopf, Mr. Gianakis, Mr. Lindeman and Chairman Gerecht; they being all members present and eligible to vote. Mr. Aroneo voted against the application.
