Mayor Rae opened the public session of the meeting at 7:39 pm.

All present recited the **Pledge of Allegiance**.

ROLL CALL: Committeeman Dorsi, Committeeman Schuler, Committeeman Verlezza, Deputy Mayor Piserchia, and Mayor Rae were present via teleconference. Also present via teleconference were Attorney Pidgeon, Administrator Malool, and Clerk Phillips.

Mayor Rae spoke about the close of the sewer to NJAW on October 22^{nd.} Thanked the entire Township Committee and various township employees that assisted with the sale.

PRESENTATIONS / DISCUSSION:

- Eagle Scout Project Tom Osmond from Troop 56 spoke about planting 56 trees varying from maple or cherry throughout the township for his Eagle Scout Project. The Township decided for Nancy Malool to be the beneficiary of the project.
- Planet Networks Upgrading and expanding fiber optic network CEO Robert Boyle spoke about wanting to expand Planet Network into Long Hill Township. At the current moment there is no intention of expanding. The Township will speak with Attorney Pidgeon about the potential resolution and follow up.
- Deck Update Mead Briggs from the Long Hill Baseball Softball Association spoke about the township allocating \$29,000 by ordinance for the completion of the deck. Mr. Briggs thanked the various families that through their discount brought them under budget and then requested to use the remaining funds to improve snack shack.

ORDINANCE 464-20 (SECOND READING / ADOPTION)

AN ORDINANCE REGULATING THE REMOVAL OF TREES, AMENDING CHAPTER XXIII OF THE TOWNSHIP CODE ENTITLED SHADE TREES IN ITS ENTIRETY

Committeeman Schuler spoke about his opposition to the Ordinance. Committeeman Dorsi asked for clarification about timelines, landmark trees and registration. A discussion ensued in regards to requiring qualifications for someone to determine the condition of the tree.

Mayor Rae OPEN PUBLIC HEARING

Clerk Phillips had received an email in regards to the Ordinance which will be read into the records per Local Finance Notice 2020-21.

Joe Huber, 70 Meadowview Rd, Millington, NJ – sent via email. - Just wanted to bring a few points to your attention, as there is an anticipated vote on Nov 12 for the Proposed Ordnance rewriting chapter 23 - Shade Tree Regulations (464-20). I'm hoping to attend the meeting tonight and on 12 Nov, but I may not be able to make tonight's meeting, as I have another commitment. That said, just wanted to share some input I had, after reading the existing ordinance, and the newly proposed one. While I'm certain there is value to updating our regulations, I recently discussed with some other citizens, and there are a few points I wanted to bring to the Town Council's attention, in hopes of a most informed vote. The currently proposed new ordinance changed the idea that a private property owner could maintain their trees, as they desire. I'll go into some detail: Should this proposed language pass in its current form:

The existing ordnance has exemptions for the following specifically cited, reducing the burden on the town and the private property owner:

- 1. Trees on properties with existing one or two family dwellings.
- 2. Trees within the JCP&L high tension line easement.
- 3. Trees specifically permitted to be removed by the Planning Board or Zoning Board of Adjustment as part of an approved subdivision or site plan.
- 4. Trees on land classified as a tree farm under State statutes.

Given the newly proposed language, exemptions 2-4 remain intact, but exemption 1 is removed. The ordinance would now require for the private property owner in all cases of a tree > 12" to submit for a permit. Absent some pressing need or additional context (ex- mandatory law/flow-down coming from NJ state, some critical situation regarding trees) I feel like removing the above exemption for personal property owners is not desired.

Here's why:

- i. As a government official, this level of review seems unnecessary and burdensome for our township government.
- ii. As a private property owner, I could see this leading to everyone just cutting down trees that are 11" in diameter or below. It could actually have the opposite effect, whereby everyone avoids the hassle and limits the size of the trees on their property.

iii. As a private property owner, I find it difficult enough to save up the money to maintain the trees on my property, make improvements, and prevent damage to my home and surrounding property, and feel like adding additional steps and approvals is only going to limit people's ability to do so, and will be unnecessarily burdensome. Further, I don't believe there is any specific benefit that is quantifiable in any realistic way, so it's hard to sell and somewhat confusing. Sometimes people remove a healthy tree because it is too close to their dwelling and has gotten too big, or they simply don't want a tree in that portion of their yard so they can optimize their use of the land they purchased. That's part of maintaining your property and owning it.

iv. Absent some additional context, it appears the residents of the town should be more concerned about the potential for property damage, the limitations on the use of their own land, and needing to 'ask permission', than the devastation of the tree population. Locally, I haven't noticed any indiscriminate clearing of trees.... in fact, we have plenty of trees all over, and most of it on private land. Has there been wide-spread issues/abuses that we aren't aware of? Long Hill is not the problem in terms of the broader context (state, country). If the whole country/world modeled their construction/land use ordinances after our practices historically, I don't think we have an issue with tree populations. The desire to maintain the character of the town and rural nature is one of the main reasons people actually fight the overdevelopment of NJ suburbs, which is far more impactful to all of the things the shade tree regulations are intended to prevent. Perhaps we can focus these policies on new zoning requirements for people contributing to overdevelopment. Isn't this the same realization that the power company came to in NJ? New Jersey discouraged utilities to not take down trees historically, but now we have a tough time maintaining power in adverse weather conditions, and causing medical risk/issues to those losing power. Finally, even if there is some context that I'm unaware of or some issue, can't we just address those issues, and not take such an all-encompassing step in this revision of the regulations? The old/existing regulations banned any clear-cutting already... so people aren't just allowed to clear a piece of land for no reason. It seems like we are trying to come down on the private property owner who now needs to remove a tree to remodel their dwelling/business, or is fearful of a tree that has grown too big near their dwelling?

Charles Arentowicz, 605 Heritage Road – Mr. Arentowicz thanked Attorney Pidgeon for saying that written comments are able to be submitted. Mr. Arentowicz went on to speak about protecting future subdivision trees that are required. Mr. Arentowicz thanked DPW Director Al Gallo for getting certification and asked about his request on the replacement trees for Heritage Road.

Dennis Sandow, 29 Windsor Way - spoke about various sections of the ordinance and a discussion ensued in regards to amending said sections. Big Tree List

Charles Arentowicz, 605 Heritage Road - asked that Mr. Sandow state his address for the record so his suggestions would be valid.

Attorney Pidgeon advised the Township Committee to amend the discussed sections and carry the public hearing until the November 12, 2020 meeting.

ORDINANCE 464-20

AN ORDINANCE REGULATING THE REMOVAL OF TREES, AMENDING CHAPTER XXIII OF THE TOWNSHIP CODE ENTITLED SHADE TREES IN ITS ENTIRETY

BE IT ORDAINED by the Township Committee of the Township of Long Hill in the County of Morris, New Jersey that the Township Code and the Township Land Use Ordinance are hereby supplemented and amended as follows:

Section 1. Title. Chapter XXIII of the Township Code entitled "Shade Trees" is amended in its entirety to read as follows:

Chapter 23 Shade Trees

Section 23-1 Purpose and Intent

- A. The purpose of this section is:
 - 1. To preserve and protect trees within the Township of Long Hill, which helps to preserve water quality, abate noise, and enhance the ambience and character of the community.
 - 2. To control the indiscriminate destruction of trees which has been shown to have severe detrimental environmental, ecological and economic effects including increased soil erosion and surface drainage problems, creation of insect breeding sites, decreased oxygen production, decreased property values and increased Township costs and thereby to eliminate a threat to the public health, welfare and safety.
 - 3. To protect the semirural character and natural resources of the Township, consistent with the goals and objectives of the Master Plan. This section is not intended to restrict homeowners from removing dead, diseased, or hazardous trees. It is not intended to restrict homeowners from conducting routine pruning of trees or other maintenance procedures.
- B. This section places special emphasis on the preservation of trees around the perimeter of a property to create Conservation Areas based upon setback requirement pursuant to the Township of Long Hill Zoning Code. The ordinance will also provide a sound management structure for the removal of trees in the Township.

Section 23-2 Definitions

Diameter at Breast Height shall mean the diameter of a tree measured 4'6" above the uphill/highest side above grade.

Enforcement Officer shall mean the Code Enforcement Officer.

Hazardous Tree shall mean a tree that musts meet the following two criteria: (1) The tree, or a tree part, must be at an increased likelihood of failure, usually due to the presence of some structural defect e.g. the presence of a significant amount of decay in a portion of the tree, and (2) there must be one or more targets present. A target may be any person or property that could potentially be damaged or injured

should a failure occur. If there are no targets present there is no risk and the tree will not be considered a hazard, even if it is structurally unsound and likely to fail at any time.

Landmark Trees shall mean any tree designated and identified by the Township Shade Tree Commission meeting the criteria for designation.

Township Trees shall mean trees located on Township property or within Township right-of-way.

Private Trees shall mean any tree other than a Township tree.

Screening shall mean one or more trees or hedges which provide a visual barrier between properties.

Tree shall mean any woody perennial plant having a diameter of six inches measured at a point 4'6" above grade.

Tree Removal Permit shall mean a permit issued by the Shade Tree Commission authorizing the applicant permission to remove a Township tree.

Tree Removal Registration shall mean a registration filed with the Township Clerk on the official Township form before a property owner or tenant removes a tree 12' in diameter or greater from private property.

Section 23-3 Responsible Officials; Enforcement

- A. .Administration. The Shade Tree Commission shall be responsible for administration of this section.
- B. Enforcement Officer. The Code Enforcement officer is hereby authorized to enforce the regulations set forth within the Township Code.

Section 23-4 Prohibition and Requirements with Respect to Township Trees

- A. It shall be unlawful to commit any of the following acts with respect to Township Trees within parks and public property or within Township right-of-way without the prior written permission of the Shade Tree Commission.
 - 1. Cut, prune, break, injure, alter or remove any tree; or cut, unduly disturb or interfere in any way with any root of a tree or trees.
 - 2. Spray any tree with a chemical.
 - 3. Fasten any rope, wire, sign, or other device to a tree or trees or to any guard about such a tree or trees.
 - 4. Install, remove or injure any guard or device placed to protect any trees.
 - 5. Obstruct access of air, water, or fertilizer to the roots of such tree or trees.
 - 6. String any wires or lines through a public park.
- B. The Shade Tree Commission shall grant such written permission if the activity for which such permission is requested is in the public interest and is not likely to materially injure any Township tree. The Shade Tree Commission has 30 days
- C. Any person or persons who cause damage to any tree(s) by machines, autos, etc. shall be held liable for damages to the tree or trees. Damages shall be corrected or repaired by the liable person or persons billed for the damages and shall be liable to the penalties set forth in section 1-5 of this Code.

Section 23-5 Tree Protection

a. Chain link fence may be required for tree protection if warranted by site conditions and relative rarity of the plant.

- b. Snow fencing used for tree protection shall be firmly secured along the dripline but shall be no less than six (6) feet from the trunk.
- c. The grade of land located within the dripline shall not be lowered or raised unless compensated by welling or retaining wall methods; and in no event shall be permitted within the dripline or within six (6) feet of any remaining trees, whichever is greater.
- d. Any excavation within the dripline, or within six (6) feet of the trunk of a remaining tree, whichever is greater, shall be done by airspade or hand-operated equipment.
- e. Where a tree that has been noted for preservation is severely damaged and unable to survive, tree replacement shall occur as provided in the Tree Replacement section of this ordinance.

Section 23-6 Landmark Trees

- A. The Shade Tree Commission or its Chair upon request, shall determine whether any tree qualifies as a "Landmark Tree". A tree may qualify as a Landmark Tree if it meets one (1) or more of the following criteria:
 - 1. The tree species is rare.
 - 2. The tree is more than one-hundred (100) years of age.
 - 3. The tree is of an abnormal height or has an abnormal trunk diameter or dripline diameter for a tree of its species.
 - 4. The quality of the tree foliage is abnormal for a tree of its species.
 - 5. The location, shade value, fragrance, erosion control, aesthetic, features or scenic enhancement of such tree is of especial importance to the Township.
- B. All trees designated as Landmark Trees, shall be shown on a map with appropriate code marks signifying each tree's designation, number, species, age, size and other distinguishing characteristics for ready reference and periodic monitoring.
- C. If the owner or owners of the property on which a Landmark Tree is located consents thereto, the Township may identify such tree as a Landmark Tree by the placement of a suitable marker thereon.
- D. If and when, any Landmark Tree is removed, the Shade Tree Commission shall arrange for the necessary changes to made to the official Landmark Tree inventory records and Township Map.

Section 23-7 Protection of Trees on Private Property

- A. Any person wishing to remove one or more trees greater than 12" in diameter, shall file a registration form with the Township Clerk which shall include a description of the tree(s) to be removed, their species, their size, their health and their location on the property.
- B. No fee shall be charged for a tree removal registration, however, failure to file the registration form before removing the trees in accordance with paragraph "A" above shall subject a property owner and/or tenant to the penalties set forth in section 23-12 below.

Section 23-8 Exemptions from Permit Requirement and Penalties

The following lands, activities and uses shall be exempt from the terms and conditions of this section and shall also be exempt from any violations or penalties.

A. Activities lawfully conducted on public lands or rights-of-way by or on behalf of a local, federal, state, county or other governmental agency or entity or utility company.

Section 23-9 Notice to Owner or Occupant to Remove or Maintain Dangerous Trees

The Enforcement Officer may require the removal or maintenance of a tree that is dangerous to public safety, at the expense of the owner or occupant of a property, upon serving written notice that the same will be removed or pruned to make the situation safe within a 30 day period.

Section 23-10 Nonliability of Township

- A. Nothing in this section shall be deemed to impose any liability upon the Township or its officers or employees or agents or upon the Commission or any of the Commissioners.
- B. Nothing in this section shall be deemed to relieve the owner and/or occupant of any private property from the duty to keep trees and shrubs thereon in a safe condition.

Section 23-11 Tree Replacement

The Shade Tree Commission may recommend that Township trees be replaced under the following guidelines:

- A. Trees should be replaced on a 1:1 basis.
- B. Deciduous replacement trees should be a minimum of 2 2.5" caliper, balled and burlapped and suitable for Zone 6 and guaranteed for two years.
- C. Evergreen replacement trees should also be balled and burlapped and of a minimum size of 7' 8' in height and suitable for Zone 6 and guaranteed for two years.
- D. In some instances, it may be appropriate to plant hedges or other screening as an alternative to replacement tree(s) if same would provide a more suitable visual barrier and/or better serve the purpose of this section.
- E. The preferred tree replacement locations should be on the actual tree removal site, however in lieu of providing a replacement tree on site, the owner of the property must contribute \$300 per tree to the Township of Long Hill Tree Fund to be used for the replacement of trees on public property or Township right-of-way.

Section 23-12 Violations and Penalties

Ay person violating or causing to be violated any of the provisions this section shall be subject to the penalties set forth in section 1-5 of the Township Code and shall replace each tree destroyed or removed in violation of this section with another tree of the same species, at least two inches in diameter measured at a point four feet above the ground. Each tree destroyed or removed in violation of this section shall be considered a separate offense. Failure to secure a permit prior to removal or destruction shall be a violation of this section.

Section 2. In case any article, section or provisions of this ordinance shall be held invalid in any court of competent jurisdiction, the same shall not affect any other article, section or provision of this ordinance except insofar as the article, section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

Section 3. This ordinance shall become effective immediately upon final passage and publication as required by law.
