#### Upon motion made and seconded, the meeting was extended to 11:15 pm.

During testimony, the Board raised several areas of concern regarding the following topics:

- Having a balance between the commercial and residential zones
  - Buffer to the residential zones
  - Storm water management
  - Parking deficiency of current site

After deliberation between the Board and the Applicant's professionals, the Board agreed that the Applicant has satisfied the concerns raised. By proposing a fence, berm and extensive vegetation, the Applicant will be creating a more clearly defined commercial zone while providing a good buffer/screening to the residential zone that will also provide a sound barrier. The proposed application alleviates the parking deficiency, solves any past storm water management issues, and the Board is satisfied the Applicant has gone above and beyond to try and mitigate any detriments to the adjoining residential properties. The Board believes that this application will better serve the community and surrounding area, therefore the benefits of approving the application outweigh any detriments.

Upon motion made by Vice Chairman Pesce and seconded by Mr. Rosenberg, the Board approved the application with conditions subject to a memorializing resolution by the unanimous votes of Vice Chairman Pesce, Mr. Rosenberg, Mr. Aroneo, Mr. Grosskopf, Mr. Johnson, Mr. Malloy and Chairman Gerecht; they being all of the Members present and eligible to vote.
