#### Public Outreach on Stirling/Millington Village Zones Report -

Meghan Huntcher, Executive Director of the Morris County Development Corporation introduced herself and noted she is working in partnership with Topology to process all the survey information provided by the residents.

Krzyzstof Sadlej of Topology gave a detailed presentation of information formatted based on the public sessions that were held and noted how the information will be useful going forward.

After the presentation, the subject of parking within the Township was discussed. Chairman Pfeil stated the Ordinance Review Committee began discussing the Township's parking issues at the request of the Township Committee. Mayor Schuler stated the Committee is in the process of placing a moratorium on parking for downtown Stirling. The primary concern is that the parking requirements are very restrictive on businesses; the Committee has not yet finalized the language in the ordinance as to whether or not the moratorium will be on parking in general or if there would be a moratorium on parking enforcement. The Committee will be reviewing the proposed ordinance at their next meeting.
